## **FIND OUT EVERYTHING YOU NEED TO KNOW ABOUT A COMPANY AND THE PEOPLE WHO WORK FOR IT.**

Public Records on Westlaw is the ultimate tool to review the background of a company.

- Search the Secretary of State corporate and limited partnership records to find out the official name, address and date of incorporation of a business, determine good-standing status, identify names and addresses of officers, partners and registered agents.
- Search the Executive Affiliation database to determine whether an individual is a principal, officer, owner or manager of a corporation.
- Use the Litigation Preparation databases to get the information you need to properly serve process on a company.

## **A HEALTHY ASSESSMENT OF A BUSINESS SHOULD INCLUDE A COMPLETE CHECKUP ON WHO OWNS WHAT.**

- To evaluate the strength of a business, use the Asset Locator databases to uncover different types of assets and their estimated value owned by businesses and individuals.

- Learn of real property assets, whether a party has transferred real property to another or has obtained additional real property, and uncover notices of default and foreclosures.
- Plus, find personal property assets, stock holdings of specific classes of shareholders and aircraft, watercraft and motor vehicle records.

## **PERFORM MORE COMPLETE DUE DILIGENCE IN RECORD TIME.**

One search can reveal the financial condition, litigation history and financial relationship of anyone.

- Use Bankruptcy Records databases to evaluate the financial status and creditworthiness of a company or individual.
- Search UCC Filings, Liens and Judgments databases to find debtors, creditors and secured parties.
- The Lawsuit Records databases reveal a party's relationship with other parties and spot litigious behavior.

## **FIND THE PERSON YOU'RE LOOKING FOR.**

Locate individuals and verify name, address and Social Security numbers.

- The People Finder databases on Westlaw cover 220 million names, 150 million households and 80 million phone numbers so you can quickly narrow down a universe of millions to a single person.
- You can search using a person's name, telephone number, last known address or Social Security number.
